

CONSTRUCTION OUTREACH EVENT

PROJECT NO. 3-60 KNOTT-MILLER HOLDER ARTESIA BRANCH REHABILITATION

March 10, 2026

The Orange County Sanitation District (OC San) will hold a construction outreach event on Tuesday, March 31, 2026, from 1:00 P.M. – 2:00 P.M. The event is open to contractors and subcontractors. Attendees will learn about Project No. 3-60, Knott-Miller Holder Artesia Branch Rehabilitation, and have the opportunity to network with other contractors.

OC SAN BACKGROUND

OC San is responsible for the collection, treatment, and disposal of wastewater for the north part of Orange County, California. OC San operates and maintains 15 regional pump stations, 388 miles of sewer pipelines, and two treatment facilities: Plant No. 1 in Fountain Valley, CA and Plant No. 2 in Huntington Beach, CA. The treatment facilities currently process an average of 185 million gallons of wastewater per day (mgd).

GENERAL SCOPE OF WORK

During the event, OC San will highlight Project No. 3-60, Knott-Miller Holder Artesia Branch Rehabilitation. This project will rehabilitate 3,900 feet of 18-inch to 45-inch sewer, rehabilitate 40 manholes, clean and inspect 2 manholes, and install 3 new manholes in the City of Buena Park. One new air jumper will also be installed in the City of La Palma.

VISITOR IDENTIFICATION AND SIGN-IN

Limited parking spots will be reserved at OC San's Headquarters. Therefore, carpooling is recommended. If parking is not available, attendees are encouraged to park in the surrounding streets.

Upon arrival at OC San's Headquarters, all visitors must show a government-issued photo identification and sign-in. Visitors must obtain a temporary visitor identification badge by providing either a driver's license, California Department of Motor Vehicles issued photo identification card, passport, or other form of identification that establishes identity. Depending on the number of visitors, waits of 30 minutes may be expected with the sign-in process. Therefore, attendees should plan their arrival accordingly.
